

## **SUMMARY ANNUAL REPORT**

### **For EASTERN ATLANTIC STATES CARPENTERS HEALTH FUND**

This is a summary of the annual report of the Eastern Atlantic State Carpenters Health Fund, EIN 22-6032181, Plan No. 501, for period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Blue Medicare Advantage and Cigna Health and Life Insurance Company to pay dental, HMO, PPO, indemnity and prepaid dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2024 were \$8,227,345.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$966,733,169 as of December 31, 2024, compared to \$952,847,699 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$13,885,470. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$345,022,490, including employer contributions of \$280,262,250, employee contributions of \$19,513,205, realized gains of \$3,721,862 from the sale of assets, earnings from investments of \$41,524,561, and other income of \$612.

Plan expenses were \$331,137,020. These expenses included \$7,166,248 in administrative expenses, and \$323,970,772 in benefits paid to participants and beneficiaries.
